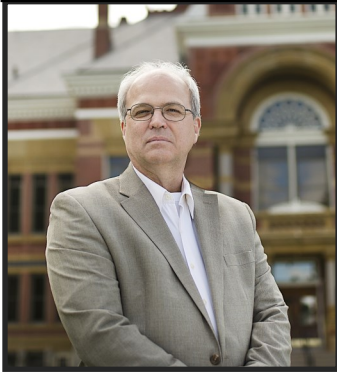

WORKING FOR YOU

Providing public services while protecting the safety of our community is our priority.

I want to take a moment to provide you with information concerning Lenawee County government's responses to the COVID 19 outbreak.

While most County Offices are now closed to walk-in business, our employees continue to maintain essential governmental functions and provide services.

Deputies still provide law enforcements and there are drop boxes located in the Judicial Building for critical court functions. Individuals having business with the Register of Deeds, Treasurer's Office, Clerk Vital Records and Equalization may call numbers available on the County website.

There is restricted access to the Sheriff's Office.

COMMUNICATIONS

We are currently having twice a day meetings with the Emergency Operations Center to plan and provide information.
